MPA fly-in events

Next events

Aircraft registrations

Six months before the expiration date, the FAA sends out notices on little postcards to remind you to renew the registration of your aircraft (this is done every 3 years). It's important to remember that this must be done 5 months before the expiration, as if it's not, it becomes sort of a pain to re-register after that.

The renewal fee is \$5.00, and it can be done on-line. The reminder notice will have a security code you have to use - if you lose that code, it can still be

done, but it's again, it's real pain. So of course, we try to avoid pain with the FAA. And you don't want to fly with an unregistered machine – same as driving with an expired license plate on your car.

What next?

During the next two weeks, I will be contacting the people in charge at the various fly-in venues we have scheduled for this year. I will set up an event with whoever is willing to have us stay overnight and use their airfield. Watch your email for the results of the search.

A recent notice by the FAA temporarily changed many of the "due" dates for the various licensing and flying activities. So for example, if yours expires in June of this year, it is now valid until the last day of September. Same with annual inspection of your aircraft.
